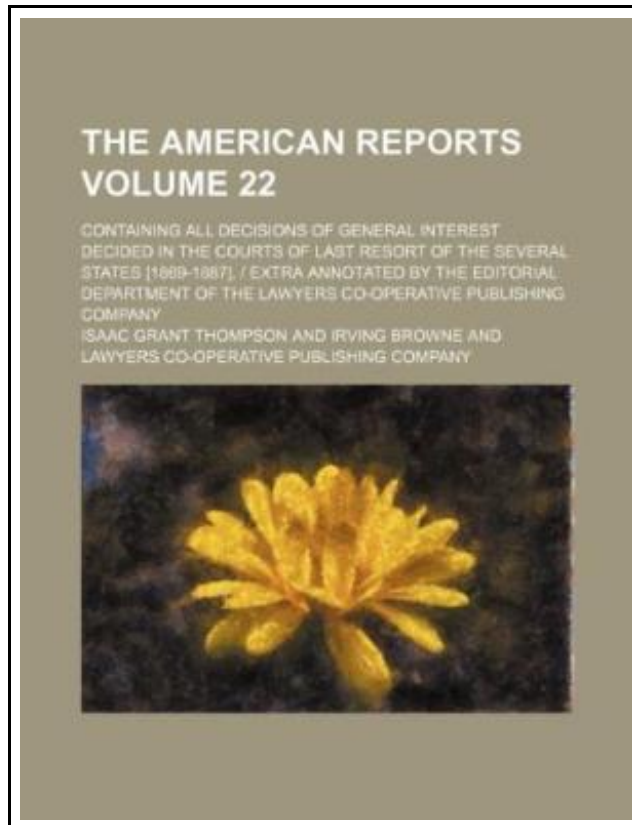

It has sometimes been supposed that this doctrine sprang from the English statute of laborers, and Whs confined to menial service. But we are satisfied that it is founded upon the legal right derived from the contract, and not merely upon the relation of master and servant; and that it applies to all contracts of employment, if not to contracts of every description. In llarl v. Alilriui , Cowp. f,4. it was applied to a case very much like the present. In Qunter v. Axlol, 4, f. U. Moore. 12, it was applied to the enticing away of workmen not hired for a limited or constant period, but who worked by the piece for a piano manufacturer. In Kheiiard v. tt akemun, Sid. 79, it was applied to the loss of a contract of marriage by reason of n false and malicious letter claiming a previous engagement. In HViisimire v. (Sreenlutnk, Willes, 577, the defendant was held liable in damages for unlawfully and unjustly procuring, enticing and persuading the plaintiffs wife to remain away from him. whereby he lost the comfort and society of his wife, and the profit mid advantage of her fortune. In J.umb y v. (li/e, 2 El. Bl. 210, the plaintiff bad engaged Miss Wagner to sing in his opera, and...
